## Society's biggest expenditure to date

The Society is about undertake its single most costly project to date.

We have engaged an arboriculturalist to advise us on the condition of the trees on the land that we own in the valley.

His advice was that unfortunately a number of trees in Treacle Wood close to Hayle Road need to be felled or seriously coppiced because they are diseased or for safety reasons.

Nobody is more opposed to the felling of trees than our chairman, but now that we have received this professional advice it would be remiss of us to ignore it.

We have therefore commissioned local tree surgeon Hoods Tree Services (run by the son of Loose Amenities Association founder Roy Hood) to carry out the work.

The expected bill will be in the region of £6,000, which will make a serious hole in our finances.

## Work Party

### Saxon Way

We are pleased to announce that Maidstone council has refused planning permission for a side and rear extension at 36 Saxon Way.

The official explanation was "The extension would be materially harmful to the spacious character of the plot, and the appearance of the streetscene and general locality, contrary to policy DM1 and DM9 of the Maidstone Borough Local Plan and the Residential Extensions Supplementary Planning Document (adopted May 2009)."

No mention of the danger to the adjacent hedgerow, which is what the Society was worried about, but nevertheless a satisfactory conclusion.
