Thanks to all who joined our Day of Action

We were very pleased with the response to our Day of Action walk in support of the Save Kent's Green Spaces campaign.

There were a lot of old faces present - and several new ones as well – all angry at Maidstone council's proposal in its Local Plan Review to allocate agricultural land at Abbeygate Farm off Stockett Lane for 250 homes.

Their proposal includes running a road corridor 20m-wide across the Walnut Tree Meadow Nature Reserve, in order to provide an access from the new estate onto Dean Street.

Most people were hearing about the proposal for the first time – and it's noticable that we haven't heard a peep on the subject from our South Ward councillors Messrs Wilby, Clark or Mortimer.

Whether or not you were on the walk, you can help defeat this proposal now by responding to the borough Council's Regulation 19 consultation on the Local Plan Review. Details on how to do so are on the back page.

Some good points to mention would be:

- A third of the land shown as the development site is in fact the Walnut Tree Meadows Nature Reserve
- It would involve the loss of prime agricultural land.
- It is not a sustainable site as there is no pedestrian footway from the proposed access onto Dean Street down into Tovil, so every movement would be by car
- It would adversely affect the setting of a listed building: the 15th century Abbeygate Place
- Despite Maidstone's policy saying there should be only an emergency access from Stockett Lane, part of the proposal site lies east of Stockett Lane, and could only be accessed from Stockett Lane itself, which is width-restricted.
